Mr. Les Huddle called the meeting to order.

1. Approval of Governing Board Meeting notes from October 15, 2019 and Executive Session Meeting notes from both November 6, 2019 and November 11, 2019.

Motion was made to approve by Dr. Rocky Killion with a second from Dr. Scott Hanback. With no questions or comments, the minutes were unanimously approved via roll call.

2. There were no guests in attendance to make any public comments.

3. GLASS Programs:

Mrs. Toni Skaggs noted that they are moving forward with decentralization phase three.

During this phase they will be looking at the 21 Essential Skills Programs, 8 ED Programs, teachers that have been “grandfathered” in the GLASS program and Mild Intervention Programs. It was also noted that all three districts are struggling to find Para’s.

4. Communication Initiative:

Mrs. Toni Skaggs gave a review of the last meeting which took place on November 14, 2019.

The topic was on behavior and included two sessions: “Establishing independence through the use of routines” and “Behavior, why it happens and changes at home that help”. Attendance total was 27 and included 12 parents, 13 GLASS and district staff members, and 2 agency representatives. Guests were encouraged to complete “exit slips” that would give us feedback for future meetings. A summary of those responses showed continued interest and focus on behavior.

As was suggested in a prior meeting, advertisements via social media and Peachjar flyers were made available. The next meeting will be April 15, 2020 at Durgan Elementary at 6:30pm. More in-depth

training on behavior strategies will be the focus. In addition, a “Resource Fair” with representatives from a variety of agencies in the area will be present to offer support to parents.
